



**DUBBO CITY COUNCIL
REVISED SALE PROCEDURE FOR STORE CATTLE SALE 19.6.20**

1. This is Phase 1 of easing the restrictions held at the Dubbo Regional Livestock Markets (DRLM) and below are the risk control measures that we will put in place to ensure that the safety of everyone involved.
3. Sale will be conducted via Lane pen selling in every second pen.
4. Social distancing of 1.5m will be reinforced before, during and after the sale by Agent announcement. Practice of safe hygiene (wash/disinfect hands, cover sneezes and coughs). The sale will be pulled up if anyone is not following the COVID-19 guidelines. Repeat offenders will be asked to leave.
5. Any re-stockers/prospective purchasers, Agents and vendors entering the DRLM **MUST BE INDUCTED** (induction can be done via the DRLM website) and must preregister their intent to enter. They must register with DSSA office (0268822523) their information by **MIDDAY THURSDAY 18TH 2020** with their DRLM induction number. **Any person not preregistered and inducted will be refused.**
6. Every person who is attending the sale must complete and provide at the entry to the DRLM, a signed COVID-19 declaration.
7. Those re-stockers/prospective purchasers, Agents and vendors who are allowed entry into the DRLM will be given at the entry when they hand over their COVID-19 form, a cattle ear tag that will be able to be hung around their neck and must be visible at all times. This number will be noted on their COVID-19 form that they hand in at the DRLM entry gate. Numbered cattle ear tags are to be provided by DSSA. Both Agents and Council will be responsible to ensure any members of the public that are not preregistered exit the facility.
8. Livestock carriers are to leave the site once unloaded unless they are a re-stocker
9. Children under the age of 16 will not be permitted entry.
10. The DRLM remains closed to the general public.
11. DRLM and DSSA to confirm an agreed programme for manning of front gate, including times for entry to be communicated to customers. Security at the gate will include two (2) Council staff member (or Council provided contractor) will be present as well as a principle agent and another DSSA representative, the details of which will be provided to Council by midday Thursday 18 June 2020. Two (2) administration support is to be provided by DSSA in relation to tail tags to ensure flow of traffic.
12. Advertising will stress the importance of all of the above including inductions. All Agents will need to relay the above information directly to those clients of theirs who wish to attend the store sale. Information will be posted on the DSSA Facebook page, DRLM Website page and Newspaper advertising.
13. Any concerns from visitors regarding access will be referred to the Agent they preregistered (or didn't preregister with) that Agent or representative must attend the gate to manage.
14. Council will liaise with NSW police to have a presence at sale and ensure their support.
